



## Expression of Interest in the Green Economic Zone (GEZ)

### Background

The Green Economic Zone project is a 717.9 Hectare green industrial park approved and designated by the Nigeria Export Processing Zone Authority (NEPZA) as a Special Economic Zone, located along the main Kaduna-Jos highway in Igabi Local Government. The GEZ is a public private partnership (PPP) project between Kaduna State Government and KK Kingdom Nigeria Limited.

The GEZ will host a 250MW Solar power plant, a garment plant, an edible oil processing plant and a host of other engineering, manufacturing, fashion, trading, services, electronics, and food processing clusters. With access to a range of competitive infrastructure like 24-hours power, security, water reticulation facility, fiber optics, waste recycling plant, warehouses, residential estate, resident-customs clearing facility, and all the benefits of a Special Economic Zone, the GEZ offers real value for money for both tenants and investors.

The GEZ, a Free Trade Zone licensed by NEPZA is developed and operated by KK Kingdom Nigeria Limited in collaboration with her partners. The Kaduna State Government will provide certificate of occupancy for tenants. Debt financing is provided by Afrexim Bank for eligible investors. Project Management Services is provided by PricewaterHouseCoopers.
